


WORKING IN THE CORONA CRISIS

due to the current infection situation, NWO has taken additional protective and precautionary measures for your protection and that of our employees. Thus, the self-disclosure is obligatory.

In the case that one or more of the following risk factors apply to you, we would ask you to understand that NWO will not allow the access to the NWO site:



If you fall into the "no deployment possible" or "case-by-case decision" category, you are asked to urgently contact your NWO contact person by phone or email to agree on an alternative. Testing cannot be done through NWO.

Self-disclosure for partner companies and visitors

Dear Sir or Madam,

in the context of the current infection with the new corona virus (COVID-19), the following self-disclosure must be made in order to be able to assess whether access can be granted. You are obliged to answer the following questions truthfully before entering the premises of the NWO. As a rule, the self-disclosure is valid for 3 days. In case of changes, a new self-disclosure is required. The current self-disclosure form must be carried and presented on request.
